With all the panic buying and stockpiling going on, leading to shortages in the shops, you might want to follow one of my household rules.

The use of toilet paper has always been restricted in our house to 1 sheet per person per visit. Now with the shortages of toilet paper in the shops this rule has been changed to 1 sheet per person per day, I have provided a hook to hang it on to dry between visits. If things do not improve soon the rule will change to 1 sheet per household per day.....

Hopefully we will still be able to produce our next magazine if the situation has improved and there are signs of things getting back to normal.

Recipe Of The Month

QUICK AND EASY PASTA BAKE

Serves 2.

150g. Penne or other Pasta shapes 400g. can Chopped Tomatoes 40g. Cheddar or Mozzarella, grated Salt and freshly ground Black Pepper.

1 tablesp. Olive Oil Butter- to grease

(Extras like Ham, Peas or Peppers, etc. may be added, if liked.)

Preheat the oven to 220c /425f. Cook the Pasta in a pan of boiling, salted water, according to the pack instructions until just tender. Drain, add the oil and toss to mix. Season with salt and pepper.

Grease a baking dish with Butter. Tip in the pasta, pour over the tomatoes and top with grated cheese. Bake for 15 - 20 mins., until golden and bubbling.


Also she has left me to look after and deal with "her garden" which I hope to be able to keep it as she planned. I still have much to learn, not just cutting the grass and hedges.

Dear Parish Councillors

I have lived in the Parish of Wigtoft for 39 years and over the past few years have been disappointed to see the increasing amount of rubbish which I am picking up when either walking in the village or around the fields with my dogs. The volume can be as much as 1 or 2 carrier bags full each time. Because of this, I asked a few friends if they would like to join me on a village litter picking morning. Our first outing, from the village hall to Clover Lane, managed to fill 5 refuse sacks, the majority of which was at the layby at the Clover Lane end of the village. The rubbish we collected was very varied but also extremely unpleasant. It included both faeces and fluid filled plastic bottles. Apparently this is not at all unusual according to the resident whose garden runs alongside the layby. This week we have had another litter picking morning and I am pleased to report that our number has grown to 4. We are now armed with high visibility jackets, protective gloves, 'Litterpickers' and red refuse bags all supplied by Boston Borough Council (BBC). We collected 3 large bags on the same route as our first organized litter pick, clearly showing that keeping litter from this area alone will, of necessity, be an ongoing and demanding task.

I have a few points to make. Firstly, it is a shame that the initiative for the litter picking had to come from the residents and not the Parish Council (PC) whose responsibilities must surely include an oversight of the cleanliness of the Village. It is even more of a shame that one of the team had to go to the BBC offices to collect the refuse collection items rather than them being available within the Village, sourced by the PC. Furthermore, A local resident, one of the volunteers, was told at your open meeting in March that a rubbish bin would not be considered for the layby even though it is the source of so much discarded litter and clearing it is such a significant task for us volunteers.

In summary I would like to make 3 points:

- 1. As you are the Wigtoft residents' advocates and representatives to the BBC, surely you should be pushing for the provision of a bin in the layby. Our task as volunteer litter pickers can be onerous and a risk assessment of what we are doing would be likely to suggest the necessity of the provision of a bin.
- 2. The PC should provide the refuse sacks, jackets and grabbers and I would suggest that they could be held at the village hall, for collection by the volunteers as this task is going to have to be ongoing as there are still many areas of the Village, and its approach roads, that are yet to be tackled. As demonstrated by our latest pick, once cleared it is not long before significant quantities of litter accumulate in the previously cleared areas.
- 3. Finally, there are a number of motor tyres dumped on the approach roads to the Village and we are unable to collect these due to their weight etc. It would be helpful if you could arrange for their collection and disposal.

Litter Picking In Wigtoft

Three ladies decided to clear Wigtoft village of litter, where does it all come from? So, armed with bags and litter pickers they retrieved five bags, full of rubbish!! An inordinate amount considering this is from the Village Hall down to the lay-by leading onto the A17! We are pleased to say that three helpers have now increased to four. If anyone would like to join them then please do so.

After an appeal to the Parish Council they were directed to Boston Borough Council. They were supplied with the necessary equipment. They also requested two litter bins, which we understand are supplied by BBC. However, at present, although much needed, bins are unavailable, perhaps in the future!

Litter Pickers will meet next on Tuesday April 20th and Wednesday May 20th at 10am outside the Village Hall. We look forward to seeing you if you are able to help. Thank you!

Topical Talk

Another hoard of Iron Age coins has been unearthed in the UK – this time in Jersey. The hoard, consisting of 69,347 gold and silver coins is worth an estimated £10 million. It was found by metal detectorists Reg Mead and Richard Miles: they found the coins after a 30 year search in a field on the island. Although the discovery was made in 2012 it has only just been officially recognised as the largest of its kind found in the UK and sets a new Guinness World Record. The find surpasses the previous record for the largest collection of Iron Age coins of 54,951 which was found in Wiltshire more than 40 years ago.

Some of the treasure is now on display at La Hongue Bie Museum in the Jersey parish of Grouville. The two finders said they had received a tip off in the 1980's from a woman who said she had spotted something that looked like silver buttons, and they spent the next 30 years looking for them.

The hoard is thought to date from about 50 BC and was discovered at a depth of only 3 feet. The Roman and Celtic silver and gold coins were entombed under a hedge in a large mound of clay weighing three quarters of a ton. It has been declared treasure as defined by the Treasure Act 1996 which means it officially belongs to the Queen, although the finders are entitled to a reward.

The world's largest hoard of coins yet found was in Brussels in 1908 when 150,000 silver medieval pennies dating from the 13th century were discovered.

A Downing Street advisor has recently caused a storm of protest when he announced that the UK does not need farmers. This suggestion came from Tim Leunig and came to light when some internal emails were leaked. He suggested that we should be like Singapore and import all our food. He went on to suggest that the UK's agricultural and fishing sections made a negligible contribution to the economy and pointed out that Singapore was rich without having its own agricultural sector: he also suggested that farmers should not be given tax breaks denied to other industries. Tim Leunig went on in his email saying "The food sector is not critically important to the UK and agricultural and fish production certainly is not". When he was challenged by fellow members of this advisory panel it appears he started to "wriggle". A government spokesman said that his comments were "not policy".

On a personal note, having lived through the last war with all its rationing and shortages and "grow it yourself" policy I think he is talking a load of "cobblers".

The recent storms threw up a surprise on the Irish coast. A ship, the MV Acta, was washed up on the coast near Ballycotton in Cork: she was a ghost ship that had been abandoned by her crew when she had been badly damaged.

The ship was sailing from Greece to Haiti in September 2018 when she was damaged beyond repair about 1380 miles south east of Bermuda. The crew were rescued by the US coastguard and taken to Puerto Rico. The 40 year old vessel was then towed to Guyana only to be hijacked: her fate was unclear until August last year when she was spotted in the middle of the Atlantic. She was then thought to have drifted up from Africa to Ireland, where she was washed up during storm Dennis.

I have just been reading about a vehicle called Curiosity. This is a driverless vehicle, but not as we know it. It is based on the planet Mars – 140 million miles from earth!

This vehicle, or rover, has been on Mars since 2012 – it was launched in November 2011 and reached Mars nine months later. It is about the size of an average car and is remotely controlled from a desk at Oxford University by Professor Scott McLennan.

The rover is conducting experiments to determine if life ever existed on the planet and it is sending large amounts of data back to Earth each day. There is evidence that, at one time, there was water on the surface.

There are plans afoot to send another rover to Mars next year called Perseverance, with the possibility, in a few years, to be able to send samples back to Earth for analysis.

Book Review - The Humans by Matt Haig

I started reading this book waiting in the doctor's surgery for an appointment and couldn't stop giggling like a mad woman - you are following an alien sent to stop human mathematical progress.

I found this book fascinating. It is written from an alien's perspective who arrives on earth naked to inhabit the body of a Cambridge science professor who has proved the Reimrnan hypophysis (a higher math's equation which could eventually lead to time travel which his race doesn't think we are ready for)

Professor Andrew Martin was an arrogant, unfeeling human whose relationship with his wife and son has completely broken down.

The alien has to adapt to human life so as not to draw attention and soon finds out that taking your clothes off in public is not the way to do this. There is a strong comic element throughout this novel and the alien is constantly baffled by human behaviour, his discovery of peanut butter sandwiches, Australian wine, Talking Heads, human relationships and sex are hilarious. He learns to be human with all our idiosyncrasies and failings.

Taken from another perspective I thought the 'alien' could be the tale of someone who had had a breakdown and was now experiencing the world as an outsider, seeing things as they really are, gaining a huge dose of perspective whilst learning to live and love.





Local Worthies

Rev James Elphinstone Roe

James Roe was born in Kirkby on Bain: his father was the Rev Thomas Roe, the local rector. Nothing is known of his early life; in June 1836 he began his studies at Oxford – he graduated with a BA in 1841 and shortly afterwards took holy orders (became a priest). In 1843 he married Susannah Moore and they went on to have 14 children, of which 9 survived to reach adulthood.

In 1841 Roe was convicted at the Old Bailey of forging a money order. It appears that he had expected to be left money by an uncle, but a cousin had persuaded the uncle to make a will in the cousin's favour just a week before the uncle's death. After the uncle's death Roe had produced a money order for £6,000, apparently made out to him from the uncle. The cousin challenged the order and Roe was charged with forgery; he was eventually found guilty and sentenced to 10 years penal labour. He was transported to what was the penal colony of Western Australia, arriving in December 1862. After serving a portion of his time he received what was known as a "ticket of leave" in August 1864 and took work as a schoolmaster at York. Four months later his family arrived in Western Australia and he met them at Freemantle. They struggled financially and they both had to work to support themselves and their family: Susannah found work in the town, teaching, and Roe himself carried on teaching some distance away.

Although Roe was highly qualified his convict status would normally have prevented him taking an official teaching post, however, Bishop Hale (of Freemantle) had sympathy for the family and helped them in his capacity as the Chairman of the Board of Education. Roe started a teaching post at Greenough in 1867 and his wife was transferred to the same school eventually and the couple were able, finally, to live under the same roof.

Because of his strong educational and religious views Roe was eventually at odds with the local Education Board and, following an incident where he was late to school, he was dismissed.

His wife continued teaching but Roe himself leased a small farm and cut sandalwood – he also acted as an agent, auctioneer and clerk: he also took on work as a local correspondent for the Freemantle Herald: in 1873 this resulted in an offer of full time work as a reporter on the newspaper. At the end of that year his wife resigned from her teaching post and the family moved to Perth where Roe took up his position with the Herald. Shortly after this he joined with two others as co-editors and he worked on the paper for the rest of his life.

Susannah his wife died in 1887 and Roe found it increasingly difficult to live on his salary from the Herald, so in 1890 he also worked on his daughter's market garden. He died in May 1897.

James Roe's daughter Helen married Patrick Stone, who later became a Member of the Western Australian Legislative Assembly. *Colin Scrupps*

Sutterton Methodist Church Services for April/May



The Methodist church will suspend all church services, events and coffee mornings until the present crisis of Coronavirus is over.

Our thoughts and prayers are with everyone at this challenging time.

Spanby

Spanby is a small hamlet close to Threekingham and is part of that civil parish. This has only ever been a small settlement – the Doomsday Book of 1088 lists the village as containing just twelve households. The parish church here is dedicated to St Nicholas, but it was declared redundant in 1973 and was sold to a local resident – it is now described as being used as a "garden shed". The building we see today is a brick built one, erected in 1882 and was built on the site of an earlier church from the 13th century. There are a number of graves in the churchyard belonging to the Cragg family.

Stow Green

This is another hamlet that is part of the parish of Threekingham: it was at one time quite a large settlement, with its own church, but today all that remains is a field at the side of the old Roman road, with a few scattered farms. Its church was dedicated to St John the Baptist and the village had very strong ties to the nearby Sempringham Abbey. The village that stood on this site has now vanished, but the site is perhaps best known for it's famous fair which was first established in 1268 and ran for almost 700 years; it was formally ended in 1915, the war being blamed, but managed to struggle on for about another 20 years before it finally ceased to exist, it consisted of many booths, erected by traders for the sale of all kinds of goods and was also well known as a horse fair and for the sale of all kinds of livestock, particularly sheep. It also had a reputation for the hard drinking that took place here. The fair appears to have taken place over a number of days in lune.

In 1826 there is a report of a serious fight or scuffle taking place at the fair resulting in someone being killed – there was a subsequent hanging related to the crime.

The Cragg Family

The Cragg family were a prominent family in the village for many years. They had a large estate which appears to have consisted of tenanted farms. This estate was broken up and sold off in the early 1950's, allowing many of the tenant farmers to buy their farms.

The family residence was Threekingham House in the village (now called Laundon Hall) and the family lived here from the late 18^{th} century to the mid 20^{th} century. There are memorials to the family in the village church. The entrance to Laundon Hall is dominated by a whalebone arch. This jawbone was erected in the 19^{th} century by the Cragg family and was a reminder of a whaling expedition that a member of the family took part in.

There is mention of a John Cragg as having lived in the village in 1705.

Two family deaths are recorded during the first world war. Lieut Noel Henry

Cragg RN was killed in action on September 20th 1915 aged 22 years and Lieut John Francis Cragg of the 8th Batt Lincs Regt killed in action on July 1st 1916 aged 28 years.

The Church

The church at Threekingham is dedicated to St Peter ad Vincula (St Peter in Chains). The present church was built on the site of a previous one, which was possibly erected to commemorate the battle fought here in 869 between the Vikings and the Saxons.

The present large church would have been made possible because of the profitable wool trade in the 12^{th} to 14^{th} century. In the churchyard (south east) is an ivy covered stump – this is all that is left of the village's Holy Cross.

As you enter the church you can see a number of floor memorials to prominent village families – these names include Hough, Quincey, Hyde and Cragg. In the late 1950's and early 1960's there was a member of the Cragg family who was vicar at Swineshead.



There are three 14th century tombs, probably of the

Trykingham family – originally these were outside but at some stage were brought inside the church; near these are the village stocks, complete with whipping post and irons.

The oldest part of the church is the tower; this was built around 1170. In the belfry are three large bells, one of which was cast in 1660. At the entrance to the vestry lie the recumbent figures of a knight in tunic and chain mail and a lady in flowing dress and veil: these are believed to represent Sir Lambert de Trikingham and his wife, who was a member of the Spayne family and from the Manor at Spanby. The ancient stone font dates back to about 1200; it is very deep and relates back to the time when children would be fully immersed at baptism. The angels depicted over the altar were carved by Belgian refugees during world war one.

The present altar came from Winchester Cathedral and was dedicated in 1962. Some of the windows show traces of colour and patterns in the window jambs; up to around 1270 the church would have been richly decorated throughout..

The carved panels at the end of the benches are 400 years old, as is the timbered roof.

To sum up Threekingham:- As with most of our seemingly small and insignificant villages, once you start digging around it is amazing what comes to light and even if you have little interest in them you do have to stop sometimes and think about what has happened in these small places in the past 2,000 years.

Clerk's Report.

Please note however that there are 5.8 hours holiday outstanding from last year and 16.8 for the current year. The Clerk has annual leave planned between the December meeting and the February meeting and will endeavor to use as much outstanding holiday as possible.

Notification has been received from Highways that there will be no further action taken regarding the overgrown trees on Wigtoft Bank or regarding the road breaking up on Green Lane.

The two replacement street lights have been ordered.

The jet washing of the equipment has been ordered. The clerk received a telephone call to say that due to the heavy rainfall, the jet washing has not yet been completed.

To discuss the quote of £600 for pruning trees in the playing field

Following the annual inspection of the trees in the playing field, it was resolved to accept the quote of £600 to undertake the necessary work to ensure the trees in the playing field are safe. **ACTION: Clerk to place the order for the work.**

To review the November monthly play area inspection undertaken by Cllr SB

Cllr SB advised that he had undertaken the play area monthly visual inspection but had not brought it to the meeting. He reported that there were no new issues to report. He will forward the report by email to the Clerk. The Clerk reminded Cllr PC that the next quarterly detailed inspection is due in December and Cllr PC agreed to complete this. **ACTION: Clerk to monitor for receipt of November inspection.**

The Chairman moved agenda item 17 to discuss prior to the budget planning agenda item below

To decide whether to pay for copies of planning applications or to continue with the present arrangement of Councillors viewing the plans online prior to plans being discussed at meetings.

The Clerk had received details of costs of obtaining paper copies of planning applications. It was resolved to continue with the present arrangement.

To complete the annual budget planning process

Forecast for electricity cost for street lights is £542.10. It was resolved to budget an additional £700 to replace two further old type lanterns with ECO LED lights. Councillors asked the Clerk to check the Parish Council insurance policy to ascertain if the policy would cover replacing street light columns if one were damaged by a car/lorry etc.

ACTION: Clerk to contact insurers and add the replacement street lamps to the April agenda.

The clerk currently has unpaid outstanding hours and holiday entitlement. It was resolved to pay any outstanding amount before the year end and increase the budget by £500.

The internal auditor has advised that the audit process is likely to be standardised by LALC in 2020 which will increase the cost. Councillors resolved that it is not necessary to have two internal audits per year and from 2020 an internal audit will be requested to be completed in April. It was resolved to budget £130 for the next financial year.

The clerk had only been able to obtain one quote from T A Blackamore Ltd for the grass cutting. It was suggested that the clerk ask for a quote from Aaron Appleby and SMV Contractors. It was resolved that the clerk e mail out the quotes for a decision to be made as the next meeting falls after the deadline for submission of the precept request.

It was resolved to budget £150 for general maintenance, £700 for tree work and £300 for capital expenditure.

Council had previously asked the clerk to contact Wigtoft News and Views to find out the cost of printing the minutes over the year. It was resolved to budget £200 for this. The clerk had also been asked to contact the Parochial Church Council to see if there were any projects being undertaken in the next year. They are fund raising to replace the heating and also remove a tree from the churchyard. It was resolved to budget for a donation of £300 toward the expenditure. It was resolved that the total donations budget should be £560.

It was resolved to join the LALC annual training scheme at a cost of £75.

ACTION: Clerk to update the proposed budget with the above figures and submit the precept request in January.

Councillor's reports

Cllr SB – commented on the state of the footpaths and agreed with the comments made in the public forum.

A resident has asked if she can plant a tree in the wildlife garden in her name. It was resolved that this should be an agenda item for the next meeting. There is a pothole on the edge of the road just at the entry to the village hall car park. **ACTION: Clerk to report to LCC.**

A mattress has been fly tipped at the junction of Golden Grove/Clover Lane.

ACTION: Clerk to report to Boston Borough Council.

Cllr BL – requested that the poor surface on Green Lane be re-reported to LCC. **ACTION: Clerk to report.** He also requested that the clerk chase for an update on the request for the repair to the 2 road signs. **ACTION: Clerk to chase.**

Clerk's report

The Clerk advises Council that the hours worked and not yet paid now stand at 0. There are 14.6 hours holiday entitlement outstanding up to 31.3.20. In line with the decision made at the last meeting, any outstanding unpaid hours will be paid prior to the end of the current financial year.

The two replacement street lights have been fitted.

The work on the trees in the playing field will be completed when the ground has dried up.

Notification has been received from LCC that a new website for Parish Councils has been set up and the existing websites will be closed down on 30.4.20. LCC are providing training which is likely to be at the LALC offices in Dunston. I have asked if there will be any on line training and have been told there will not be. I have also e-mailed Boston Borough Council to ask if they would have meeting facilities to hold a more local training session. A reply has been received confirming that they are liaising with LALC.

The broken road signs on Green Lane/Burtoft Lane South and Burtoft Lane North/A17 have been reported to Boston Borough Council.

No interest has been shown in entering the annual Best Kept Village competition following the request in Wigtoft News & Views asking for residents' opinions about entering and asking for volunteers.

To review and decide on the quotes for the grass cutting

Quotes had been received from 3 contractors. Councillors considered the quotes and decided that flexibility around the number of cuts was as important as the cost as they like to keep the grass cut quite short. It was resolved to award the work to Appleby Services at a cost of £70 per cut. It was resolved that the budget figure for grass cutting that had been set for 20/21 is to remain the same and surplus funds will be used to cover the additional cost. It was also resolved to review this course of action at the end of this year.

To discuss the plans for the Annual Parish Meeting to be held prior to the March meeting on 2.3.20

It had previously been decided to hold the above meeting at 6.30~pm on the 2^{nd} March 2020 prior to the usual monthly meeting at 7 pm. The meeting had been advertised in Wigtoft News and Views to ensure residents are aware of the meeting. It was resolved to invite representatives from the Village Hall Committee, the Bowls Club, the Gardening Club, the Parochial Church Council and Wigtoft News and Views

To receive and review the November play area inspection undertaken by Cllr SB and the quarterly inspection undertaken by Cllr PC in December.

The December quarterly inspection report had not been received. The November play

area report was undertaken by Cllr SB. The only finding was that there is concrete showing around the top of the small embankment slide.

ACTION: This area to be checked at the next inspection. Clerk to chase tree cutting and jet washing of play equipment.


