There are fields of cabbages rotting all around us, it smells like pig fodder.

The mud on the roads and verges will be a nightmare when it freezes, so take care in your car or even walking your dogs. It is broken bones waiting to happen.

Stinging nettles, which are weeds, are a fantastic companion plant. Growing them amongst herbs alters the chemical compounds within the plants which increases their essential oils and flavours. They are good for the soil, they withstand slugs and snails so make up a compound and spray affected plants, Hostas etc..

Topical Talk

I was looking at a programme on the TV recently about the Nazi occupation of Guernsey during the last war. For whatever reason, Hitler decided to heavily fortify the island, probably expecting us to try to retake it.

The UK government decided not to defend the Channel Islands early in the war but allowed the Germans to walk in unopposed – we probably did not have the ability at the time to do anything about it, seeing that it was so soon after Dunkirk. The German fortification of the island was massive – huge guns around the coast with reinforced observation posts all round the island and a massive 360 degree cannon in the centre of the island which could fire shells for 20 miles in any direction – all connected by underground tunnels with their own power supply and storage facilities.

All this was probably in vain because when the allies invaded France at the Normandy landings they bypassed the Channel Islands, but in doing so it cut the supply line to the islands consequently, by the time the war ended, not only were the islanders suffering from near starvation, but the German troops also.

We visited Guernsey in the late 1960's and had a tour round one of the underground facilities; this had been a hospital and it was huge, all built with reinforced concrete. We were told by a guide about the thousands of slave labourers that were employed in the construction of the fortifications – they were mainly Russian and east European POW's and their treatment was horrific. They were literally worked to death and their bodies were thrown into the wet cement that was used for construction; so the walls and floors of these places became the burial place for probably hundreds of these unfortunate slave labourers.

An article in the Times on Oct 17th caught my eye. It stated that the remains of Captain Matthew Flinders, who led the first circumnavigation of Australia, were to be brought home to the place of his birth at Donington. They were identified by experts excavating St Johns burial ground in Euston, central London as part of the HS2 rail project. Members of his family are buried in the churchyard of St Mary and the Holy Rood and Flinders, who died in 1814, left instructions for four marble slabs to be placed in the church to commemorate him and his forefathers. There is also a stained glass window and a display marking his life. The report from the Times goes on:- The Rev Charles Robertson said "it is with great honour and joy that we received the good news that the mortal remains of Captain Matthew Flinders will come to

Donington. It is a privilege to welcome home this great explorer to rest in peace in his home church."

Another newspaper report recently named a man from Edinburgh, Richard Martyn Turner, as the victim of a shark attack in the Indian Ocean. He was on holiday with his wife on the island of Reunion and went for a swim in the Hermitage Lagoon alone. When he did not return the alarm was raised and a search was launched. No body was found but four sharks were later caught in the "safe" lagoon and when a post mortem was conducted on them a human hand was found in one with a wedding ring on, which was later identified as belonging to Mr Turner.

In Australia a puppy snatched by an eagle and dropped into the back yard of a house has captured the imagination of Australians – it turns out that it is a rare alpine dingo. The home owner, in Victoria, took it to a nearby animal hospital where it was identified. After treatment DNA testing confirmed that it was a pure alpine dingo, the rarest and most endangered of the country's native dogs.

A tiny Scottish island with just six inhabitants is set to see its population increase dramatically. The 4,000 acre island of Ulva in the Inner Hebrides is inviting people and businesses to relocate there. There are many ruined cottages on the island which will be renovated. So far 350 people have registered an interest.

Jamie Howard, a member of the family that owned it, has just left the island because he is unhappy about the sale of the island. It was the subject of a community buy out in June last year. His grandmother bought the island in the 1940's for £10,000.

Farming Report

As it has been several months since I have done a farming report for the Village Magazine, I will do one for the December issue. Although, it will be mainly bad news I am sorry to say.

The rape harvest went quite well in August/September, but then we started to have some really heavy storms, which in turn flattened a lot of early wheat down to the ground, making the combining much slower and making it a lot smaller grain, which then makes a lower bushel weight. Unfortunately, the wheat was high in moisture, so there was extra cost in drying, as it has to be below 15%, to store in big heaps in the stores in the yard.

People have said for years that Farmers are always grumbling and miserable but this year I really do think it is justified as it has gone on for so long.

To make matters worse, since late September/October and all of November it really does seem to have rained most days, probably the worst that I can remember in 60 years in Wigtoft on our own farm. We have not drilled one acre of wheat and only ploughed two fields, so it really is very serious.

The Farmers who grow potatoes are even worse off, as many have only lifted 50% of the crop and it is unlikely that any more will be lifted until the New Year due to the ground being completely sodden. The vegetable growers have also had a difficult time just getting the Brussels, white and red cabbage to a hard road, making very deep ruts in the field.

My apologies for being all doom and gloom but I am only reporting the honest facts. In spite of my report I do wish the people of Wigtoft a Very Happy Christmas and hope we will all have better weather in 2020.

Threekingham

The village is situated at what was an important crossroads during Roman times: the Grantham / Donington road is known as Salters Way which passes through the village (before the bypass) and was an important trade route between the salt producing area around the Wash and the settlements situated in the Midlands. The other road at the crossroads is the old Roman road, which was known as King Street, part of which is now Mareham Lane, linking Bourne to Sleaford. One of the great Roman engineering feats lies just east of the village – this is the Car Dyke, built to retain the water off the higher ground that ran down to the Fens and provide a canal route between Peterborough and Lincoln; parts of this Dyke are still visible today.

It is thought by some that the village was initially called Laundon but changed its name after a nearby battle with the Vikings in which three Viking kings were killed, but this is now thought to be unlikely.

The village appears to date from around 500/600 AD when the area around the crossroads was settled by Saxon invaders – possibly by a tribe with the name of Threcginhas, from which the village got its name. One of the earliest written references to the village relates to the death of St Werburgh; she was the daughter of the first Christian King of Mercia, by the name of Wulfhere – she died in a nunnery at "Threekingham" on February 3rd 699. there is no evidence of where this nunnery may have been sited; there are other references to a Friary in the village prior to the Black Death and one of the fields, in 1911, north of the village, was known as Monks Field.

The Danes

The Anglo Saxon Chronicles of 787 mark this year as the start of the Viking invasions of the east coast. These continued sporadically for a number of years until about 850, when the first major invasion took place. In 865, what was described as a "great army" of Danes landed in East Anglia and overwintered there. This Viking army was led by Ivar, Halfdan and Ubba. After moving north to York they returned south in 869 to East Anglia. It would be at this time that the Danish army made its camp near to the crossroads at Threekingham, this being an important point on the then transport routes. These forces had been harried by the Anglo Saxon forces over the preceding years, then, on September 22nd 869 these forces gathered together to do battle with the Danes. They attacked the Danes at the crossroads: there were, by all accounts, about 800 Saxons led by Earl Algar, 200 men from the Crowland Monastery as well as 300 men from Deeping, Langtoft and Baston, all supported by the sheriff of Lincoln with about 500

men. They assembled at Stow Green and launched their attack towards the Danish camp at the crossroads. On the first day, taken by surprise, the Danes lost a large number of men, including three kings. They retreated to their base camp and defended themselves. They buried their dead overnight to the north of the village, the three kings being interred in burial mounds – one of these mounds can still be seen in a field to the west of the village.



Overnight the Danes received reinforcements and on the second day the Saxons again engaged with the Danes: by nightfall, the battle still raging, the Danes changed their tactics and made as if to retreat – this tactic led to the Saxons breaking into smaller parties to go in pursuit; the Danish ruse worked and the smaller parties of Saxons were re-engaged by the Danes, rounded up and killed, almost to a man: very few of the Saxon troops lived to tell the tale.





Local Worthies

Ethel Lillie Major

Ethel and Arthur Major lived in a council bungalow in Kirkby on Bain: Arthur had served in the Great War and had been wounded.

He courted and married Ethel Lillie Brown who, unbeknown to him, was already the mother of a young daughter who had been brought up by her parents as Ethel's sister.

The Majors had a son Lawrence who had been born in 1919: by all accounts Arthur was a drunkard who came home nearly every night drunk. Things got so bad that Ethel and her son got to the stage where they would walk to her



parent's cottage a mile away to sleep at night: there was gossip about Ethel's daughter/sister and Arthur challenged her about it; she admitted that she was the girl's mother but refused to name the father – after that the marriage was more or less over.

In 1931 Ethel took out a summons for separation and maintenance but did not proceed with it after Arthur promised to reform. However, this did not happen and at the beginning of May 1934 she found letters to her husband that were signed "Your loving sweetheart Rose". After this it was a marriage in name only. On May 22nd of that year Arthur got home from his work at a local quarry and prepared his own supper; later that evening he collapsed in great pain and his wife and son helped him to bed. Ethel's father called later that night and found Arthur in great pain with his legs jerking and he was foaming at the mouth; when a doctor was called he diagnosed an epileptic fit and gave him medication. Ethel took him a cup of tea the next morning but her husband remained in a stupor all that day. When the doctor called again he thought that the patient was much better. In the evening the convulsions returned and Arthur died in great pain on May 24th, about 48 hours after falling ill. Ethel contacted the undertaker and arranged the funeral, but the doctor had not been contacted. When this finally happened the certificate said that Arthur had died of an epileptic fit. Two days later, as Ethel and her relatives were preparing to go to the funeral the police arrived and postponed it. It seems that they had had an anonymous letter that mentioned the fact that a neighbour's dog had died when it had eaten some food left out for it by Ethel. An autopsy was carried out on the dog and on Arthur as well and the results showed it both had died from strychnine poisoning, and it was later proved that that had been administered in corned beef that Arthur had eaten for his supper on May 22nd.

Ethel was arrested and it was proved that she had access to a locked box her father, a gamekeeper, had in which he stored strychnine for use in vermin control.

Ethel was tried at Lincoln in 1934 and found guilty of murder, but with a strong recommendation for mercy. The judge rejected this and she was sentenced to death – she was hanged at Hull prison on Dec 19th 1934, being the only woman prisoner to have been hanged at Hull.

Cllr SC advised that he has been contacted by the pest control company who currently look after the play area. The Clerk advised that a written quote would be required. The contractor has since reported the following cuts: 4.7.19, full cut; 14/7/19, strimmed; 15.7.19, full cut; 23.7.19, full cut.

The article for Wigtoft News and Views from the Chairman and Vice-Chairman has been sent. There will be no charge.

Highways have advised that a further inspection has been completed regarding the Parish Council's report about poor visibility when joining the A17 from Burtoft Lane South and that no further work will be undertaken.

The Clerk advised Council that hours worked by the Clerk from 1.4.19 to date are currently 20 more than the 4 hours per week target. This is due to the heavier work load at the beginning of the financial year. There are also 5.8 hours holiday unused from last year. With no meeting in September, the Clerk expects that this will be substantially reduced. A further report will be made at the October meeting.

The Clerk has not had time to find out the owner of the track running by the play area. Hopefully this will be completed in time for the August meeting.

Cllr PC – had received a report from a resident asking if the wildlife garden could be tidied up. Cllr PC offered to do this. Also received a report from a resident about overgrown trees on Wigtoft Bank. **Clerk to report to Highways.**

No other Councillor's reports received.

Clerk's Report.

Update on benches treatment requested 13.8.19. The Clerk was advised at that time that the work was due to be completed imminently. Further update requested 30.9.19.

The Clerk advised Council at the August meeting that hours worked by the Clerk from 1.4.19 to date are currently more than the 4 hours per week target. This is due to the heavier work load at the beginning of the financial year. There are also 5.8 hours holiday unused from last year. This excess currently stands at 11.5 hours plus the unused holiday hours from last year. A further report will be made at the November meeting.

Grass Cutting reports and quote for pressure washing the play area equipment:

It has been reported to the Clerk that the playing field grass was cut on the 4/7; 14/7; 23/7; 12/8 and 27/8.

The Clerk requested a quote for jet washing some of the play area equipment on the 14.8.19. This has not been received and was chased on 3.9.19 and 30.9.19.

The Clerk contacted Boston Borough Council regarding the original request for an additional dog bin in March 2019. A reply has been received stating that the street cleaning/bin emptying is still under review and therefore any new bins cannot be ordered.

The Clerk has requested the annual inspection of the trees in the play area/playing field.

The Clerk attended a Clerk's Liaison meeting at Boston Borough Council on 26.9.19. Agenda items were about the new Code of Conduct, Declarations of Interest, Standing Orders – when can they be suspended and when not, Dispensation requests and recording of advice given to Council by Clerks.

To discuss the quotes received for mole control in the play area.

Two quotes had been received, one for £300 per annum and one for £450 per annum. It was resolved to clarify whether the cheaper quote was like for like with the more expensive one i.e. would the Clerk need to notify the contractors when mole activity was seen. **ACTION: Clerk to obtain clarification.**

To decide whether to undertake a half year internal audit

The Clerk advised Councillors that a quote had not been received. It was resolved to request an internal audit providing costs are the same as the last internal audit. **ACTION: Clerk to check cost and request audit if appropriate.**

To discuss the e mail received from Boston Borough Council about 2 street lights which need replacing at a cost of £350.

Following a discussion, it was resolved that the Clerk should contact Boston Borough Council to find out how many old and new type street lights there are in the village and what reduction in running costs there would be if the Parish Council were to spend £350. **ACTION: Clerk to action the above.**

To discuss the annual play area inspection and review the September monthly inspection undertaken by Cllr SC.

There were no areas of concern arising from the annual inspection undertaken by Wicksteed. All areas were classed as low risk. There were some advisory comments about future regular checks. The monthly check by Cllr SC did not reveal any areas of concern. The pressure washing of the play equipment and shelters is in hand. The August inspection highlighted a damaged area of perimeter fencing. Cllr PC offered to repair this as soon as he is able.

To commence the annual budget planning process

The Clerk asked Councillors to consider any areas of required spending for the next financial year in advance of the next meeting.

To commence the planning of the Annual Parish meeting

It was resolved to hold the Annual Parish meeting on the first Monday of March 2020. **ACTION:** Clerk to advertise the meeting and invite relevant groups and committees to the meeting.

To discuss the fact sheet received from the National Association of Local Councils about the use of personal e mail addresses and devices by Councillors (in respect of Data Protection).

The fact sheet had been sent out to Councillors. The key details were discussed and Councillors were made aware that they should not be using a shared e mail address or sharing any information contained in Parish Council e mails with anyone. They were also made aware that if they retain any Parish Council documents, they must not contain any personal data. It was resolved that there should be a quarterly agenda item reminding Councillors of the above. **ACTION: Clerk to add to the agenda quarterly.**

To discuss the response from the Council's Insurers following the query at the August meeting.

The Clerk advised Councillors that the Insurers have confirmed that the policy covers up to £500.000 for Legal Liability and Legal Expenses which covers certain legal disputes and includes employment issues.

To decide if anyone is to attend the Resilient Communities Conference

It was resolved that no one would attend.

To discuss whether to enter the Best Kept Village Competition for 2020, what actions are required and whether to involve residents.

Following a discussion, it was resolved to place an item in the village magazine asking residents if they think it is a good idea and would they like to get involved with putting the application together. ACTION: Clerk to put an item in Wigtoft News and Views to ask the above questions of residents,

To set a date for the Clerk's annual review.

It was resolved to hold the review at 18:45 prior to the December meeting. The review will be undertaken by the Chairman and Vice-Chairman.

Meeting closed at 20:45

Next meeting is on the 4.11.19 at 19:00.
